Three of the water districts, Aurora, Denver, and East Valley have imposed mandatory watering restrictions (please see the other areas of this chart for the details). <sup>1</sup>Broomfield has an Ordinance, entitled Misuse of Treated Water, which prohibits excess application of water which results in a flow exceeding five gallons per minute leaving the property. So while there are currently no mandatory water restrictions in place, nonetheless, Broomfield will be enforcing this Ordinance.
